Authorized Dealers must submit advertising proofs and get written approval from the Company to advertise in trade magazines, local publishing add copy, e-mail or web news letters. The Dealer agrees to maintain a functioning web link to Gear Box Pro Ltd. on their web site(s). The Dealer is required to provide current information about itself on file with the Company. This includes, location address(s), phone numbers, e-mail and web info of the Dealer and the names of all sales staff representing the Dealer. The Dealer agrees to not publish any sales promotion pricing of Gear Box Products below the current Dealer MAP price column.

#### 3. **Dealer Web Access Codes**

When available, Gear Box Pro Ltd. will provide the Authorized Dealer with a dealer access code to enable On-Line order processing at Dealer prices.

Gear Box Pro reserves the right to activate, change, or de-activate the Dealer access code.

The Dealer agrees to keep this access code, all dealer pricing, including all administrative correspondence to and from Gear Box Pro Ltd., as confidential.

The Dealer agrees to report the discovery of any manufacturing defect within 3 business days.

Current return authorization procedures are posted on the Company web site and may be changed periodically.

# 4. **Product Integrity**

Neither you nor your employees, contractors, agents or any other person may modify, reverse engineer, decompile, decrypt, or otherwise disassemble any of the Products, in whole or in part. Gear Box reserves the right, upon reasonable notice, to have independent auditors examine your facilities and records regarding such practices. Furthermore, you agree that you will not remove, alter, cover or obfuscate any of the trademarks, trade names, logos, patent or copyright notices or markings, or add any other notices or markings to or on the Products without the express written authorization of Gear Box. By purchasing these products, you are agreeing to these terms.

## 5. **Termination**

Either party, with or without cause, may terminate this agreement at any time, with 30 Days written notice. When mutually agreed the time can be reduced but not increased.
